

## **CUSTOMER/SUPPLYING LIGHTING TEXT UNDER THE LAW ON THE PROTECTION OF PERSONAL DATA**

This Lighting Text; Kahveci Otomotiv San. Ve Tic. Aş. where you buy or sell goods/ services. (Coffee shop Automotive or Data Controller) under section 10 of the Personal Data Protection Law No. 6698. In accordance with article 2011, to fulfill the lighting obligation of the data controller, it has been prepared in accordance with the Communiqué on the Procedures and Principles to be followed in the Ful filling of the Lighting Obligation.

Kahveci Otomotiv; it shows the utmost sensitivity to the processing of your personal data in accordance with the relevant legislation and basic principles in the field of protection of personal data and to ensure the security of your personal data by taking every necessary administrative and technical measure.

Your personal data will be processed by Kahveci Otomotiv in accordance with the procedures and principles described below.

### ***1) Data Controller ID***

Your personal data is "3. Org. San. Boll. 13 Sk. No:19 Selçuklu / KONYA" at Kahveci Otomotiv San. Ve Tic. Aş. is processed by the data controller.

### ***2) Purposes for Processing Your Personal Data***

Your personal data; conducting activities in accordance with the subject, conducting finance and accounting affairs, conducting contract /product/services loyalty processes, monitoring and conducting legal affairs, conducting communication activities, conducting logistics activities, conducting goods/services purchase/sales/after-sales support processes, conducting customer relationship management processes, conducting activities for customer satisfaction, conducting marketing analysis studies, conducting advertising/campaign/promotional processes, conducting contracting processes, conducting sponsorship activities, tracking of requests/ complaints , processes are limited to the purposes of carrying out their processes and informing authorized persons, institutions and organizations.

Your personal data will not be processed for different purposes other than for the purposes for which it is mentioned and will not be used for these purposes.

### ***3) To Who and for What Purposes Your Personal Data May Be Transferred***

Your personal data; From Kahveci Otomotiv side, the execution of activities in accordance with the legislation, informing authorized persons, institutions and organizations, monitoring and conducting legal affairs, conducting contract processes, conducting finance and accounting affairs, conducting logistics activities, ensuring the security of very I responsible operations, purchasing goods/services/ sales / conducting after-sales support processes limited to the purposes of execution; third parties or institutions in which the data controller receives services or cooperates, to the subsidiaries and partners of Kahveci Otomotiv, may be transferred to the authorities authorized by law.

### ***4) Method and Legal Reason for The Collecting of Your Personal Data***

Your personal data: "the express consent of the personal data owner", " the processing of personal data belonging to the parties to the contract is necessary, provided that it is directly

related to the establishment or performance of a contract ", " itis mandatory for the data controller to fulfill its legal obligation", "Data processing is mandatory for the establishment, exercise or protection of a right." and "the legal reasons for which data processing is mandatory for the legitimate interests of the data controller, as not to harm the fundamental rights and freedoms of the person concerned".

This processing activity takes place by filling out the form or in other written procedures, by telephone or e-mail messages.

***5) Section 11 of the Personal Data Protection Law No. 6698. Your Rights Listed in the Article***

Provided that you are concerned with the application you can make in accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller or in accordance with the application form at [www.kahveci.com.tr](http://www.kahveci.com.tr) and the Application Principles and Application Form to the Data Controller at the same address.

- i. Find out if personal data has been processed,
- ii. Requesting information about personal data if it has been processed,
- iii. To learn the purpose of processing personal data and whether they are used in accordance with their purpose,
- iv. To know the third parties to which personal data are transferred at home or abroad,
- v. Request correction of personal data in case of incomplete or incorrect processing and notification of the transaction made in this context to third parties to which the personal data are transferred,
- vi. Although it has been processed in accordance with the provisions of the KVKK and other relevant laws, requesting the deletion or destruction of personal data in case of the disappearance of the reasons that require its processing and requesting that the transaction carried out in this scope be reported to the third parties to which the personal data are whitened,
- vii. Objecting to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- viii. You may use your rights to request damage relief if personal data is damaged unlawful processing.

Your application to use your mentioned rights will be answered as soon as possible and within 30 days at the latest after reaching Kahveci Otomotiv through the communication channels you have shared and preferred.
